PUBLIC DEBT MANAGEMENT ACT

(Cap 302)

International Bank for Reconstruction and Development - Global Environment Facility Debt Order, 2020

In exercise of the powers conferred by section 28 of the Public Debt Management Act, the Minister responsible for Finance makes the following order —

1. This order may be cited as the International Bank for Reconstruction and Development - Global Environment Facility Debt Order, 2020.

Citation

2. The Minister responsible for Finance has, in accordance with the provisions of section 4 of the Public Debt Management Act raised a loan for and on behalf of the Government from the International Bank for Reconstruction and Development as an implementing entity of Global Environment Facility under an agreement dated the 15th October, 2017 the particulars of which are stated in paragraph 3.

The Loan

3. The particulars of the Loan Agreement referred to in paragraph 2 are as follows —

Particulars

- (a) Parties to the transaction:
- (i) International Bank for Reconstruction and Development as an implementing entity of Global Environment Facility;
- (ii) Republic of Seychelles;
- (b) Amount of USD 5,000,000/- (United State facility: Dollars Fives Million only);

(c) Purpose of the Facility:

Programme Financing;

(d) Terms of repayment:

payable on every 15th February and 15th August commencing on 15th February, 2028 until 15th

August, 2057;

(e) Interest payable:

Service charge payable shall be equal to one-fourth of one percent (1/4) of 1%) per annum;

(f) Manner to be

accounted for: To be treated as financing;

(g) Other particulars:

Other particulars are contained in
