INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS

Report on the audit of the Financial Statements

#### Opinion

We have audited the financial statements of **Bank AL Habib Limited - Seychelles Branch** ("the Branch"), on pages 4 to 41 which comprise the Statement of Financial Position as at October 31, 2021, and the Statement of Profit or Loss and Other Comprehensive Income, Statement of Changes in Equity and Statement of Cash Flows for the period then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the Financial Statements give a true and fair view of the financial position of the Branch as at October 31, 2021, and of its financial performance and its cash flows for the period then ended in accordance with International Financial Reporting Standards (IFRS), the Seychelles Companies Act, 1972, the Financial Institutions Act, 2004 as amended and the regulations and directives of Central Bank of Seychelles.

#### Basis of Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Branch in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit of the financial statements in Seychelles, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Emphasis of Matter

##### Closure of the Bank

The Central Bank of Seychelles in a letter dated September 13, 2021, approved the request made by the Management of Bank AL Habib limited - Seychelles Branch to close its business in Seychelles by November 30, 2021. All obligations and other creditors of the Bank were settled as at the period end and the Bank is expected to surrender its banking licence by November 30, 2021. Once the licence is relinquished, the Bank will be liquidated. Consequently, the Bank is no longer a Going Concern as at October 31, 2021 and the financial statements have been prepared on a break-up basis. (See note 26).

- In our opinion, the financial statements have been prepared on a basis consistent with that of the preceding year and are complete, fair and properly drawn up and comply with the Financial Institutions Act, 2004 as amended and Regulations and Directives of the Central Bank of Seychelles.
- The explanations or information called for or given to us by the employees of the Branch were satisfactory.
- The Branch did not carry out any fiduciary duties for the period under review.
