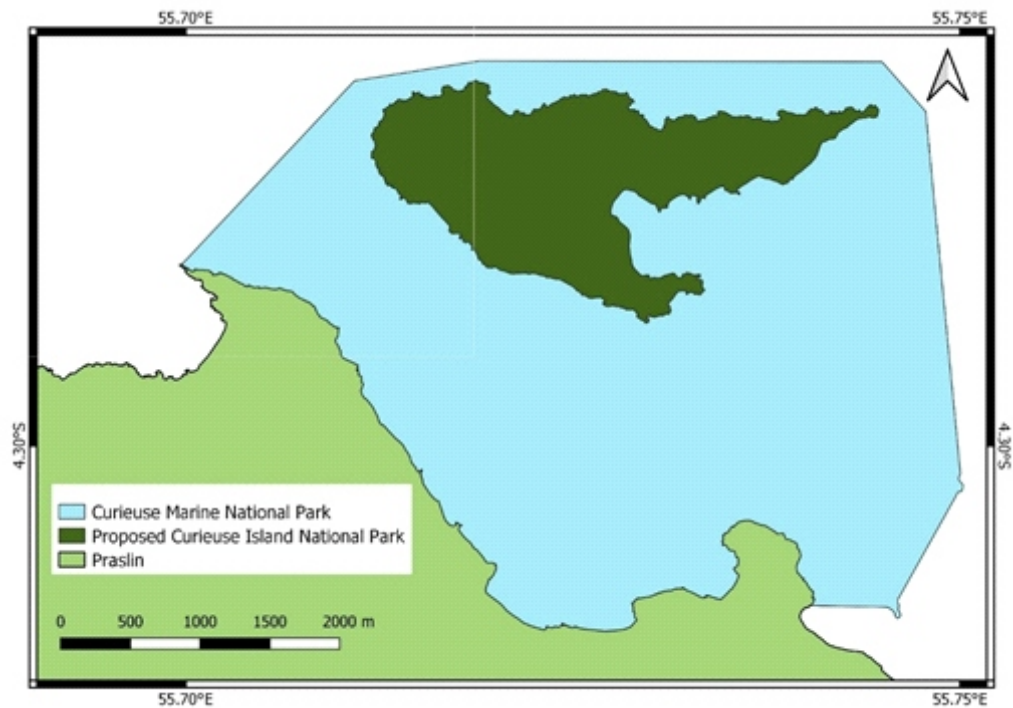

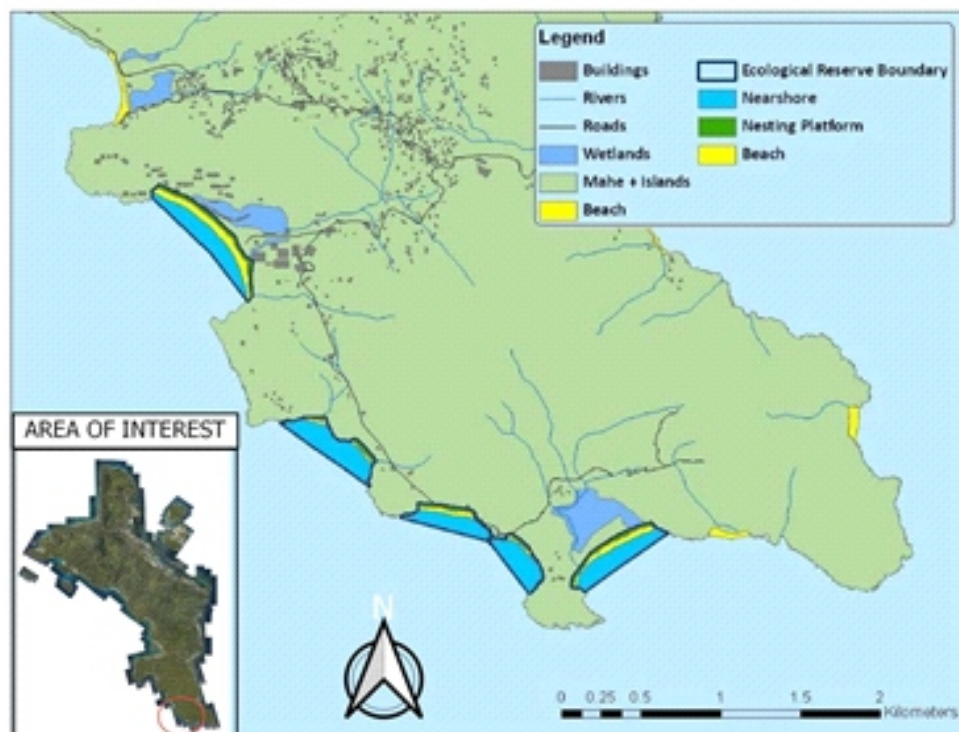


Figure 1. Delineated boundaries of all sites for nomination; Anse Intendance, Anse Cachée and Anse Corail, Anse Bazarca, Anse Petit Police and Anse Grand Police.

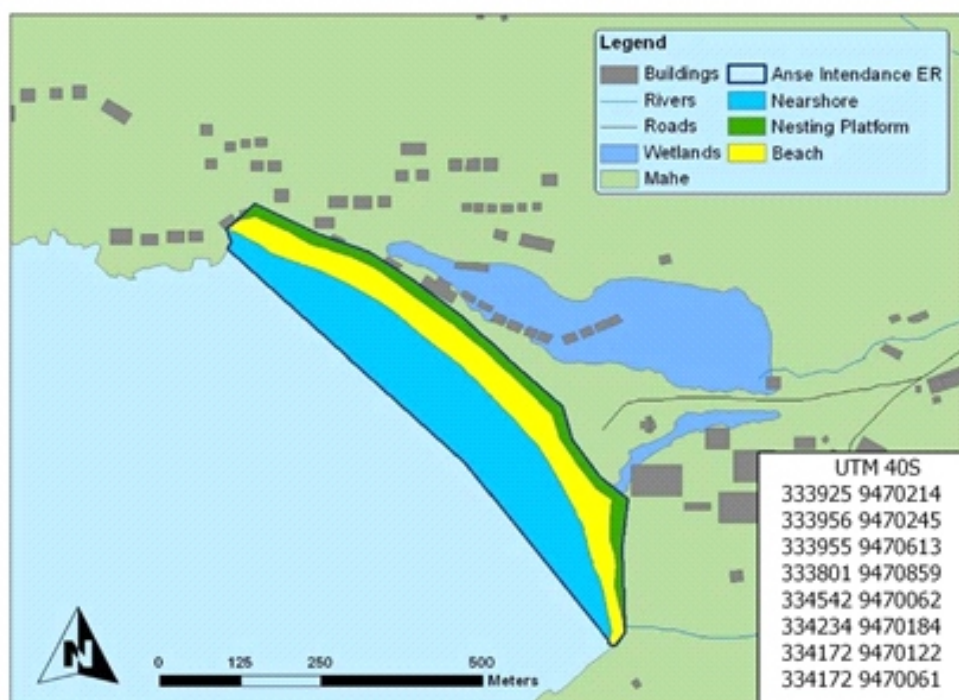


Figure 2. Delineated boundary of nominated site Anse Intendance.

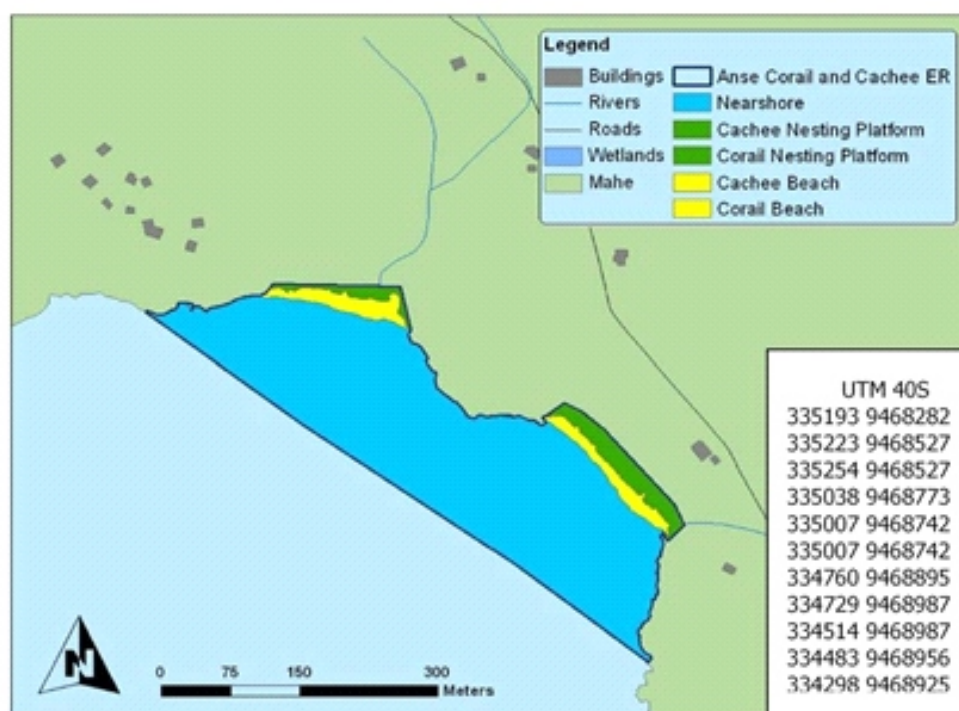


Figure 3. Delineated boundary of nominated site Anse Cachée and Anse Corail.

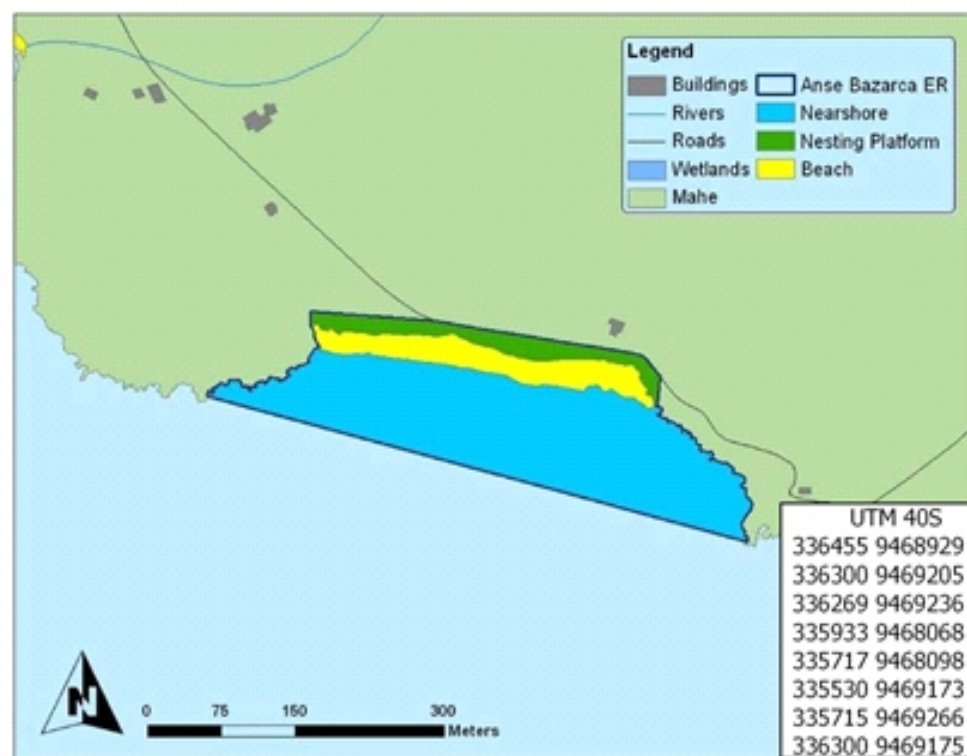


Figure 4. Delineated boundary of nominated site Anse Bazarca.

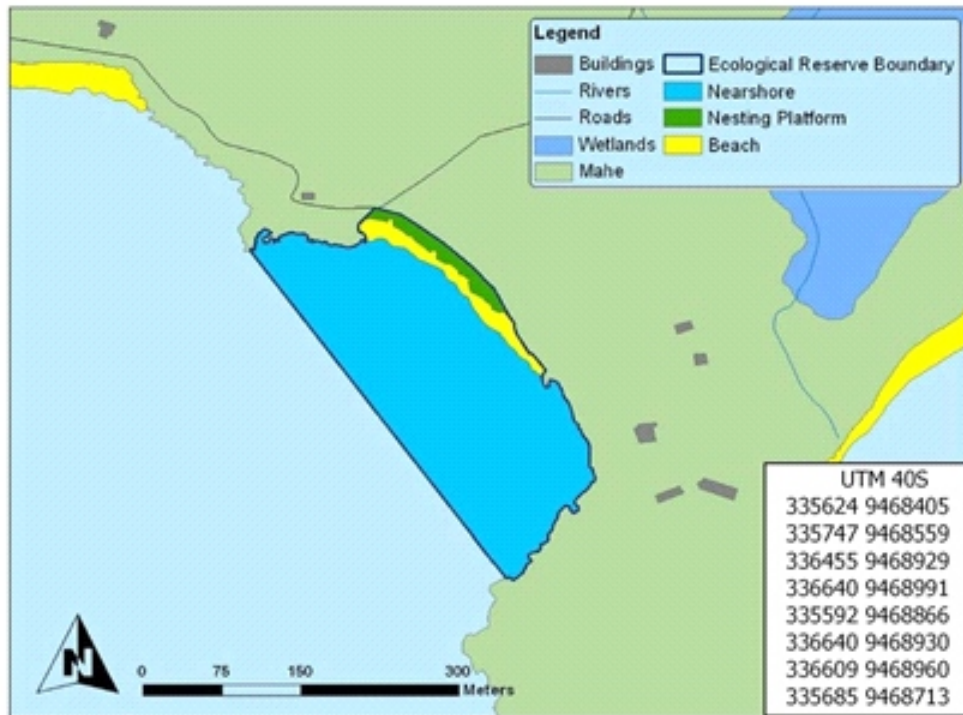


Figure 5. Delineated boundary of nominated site Anse Petit Police.

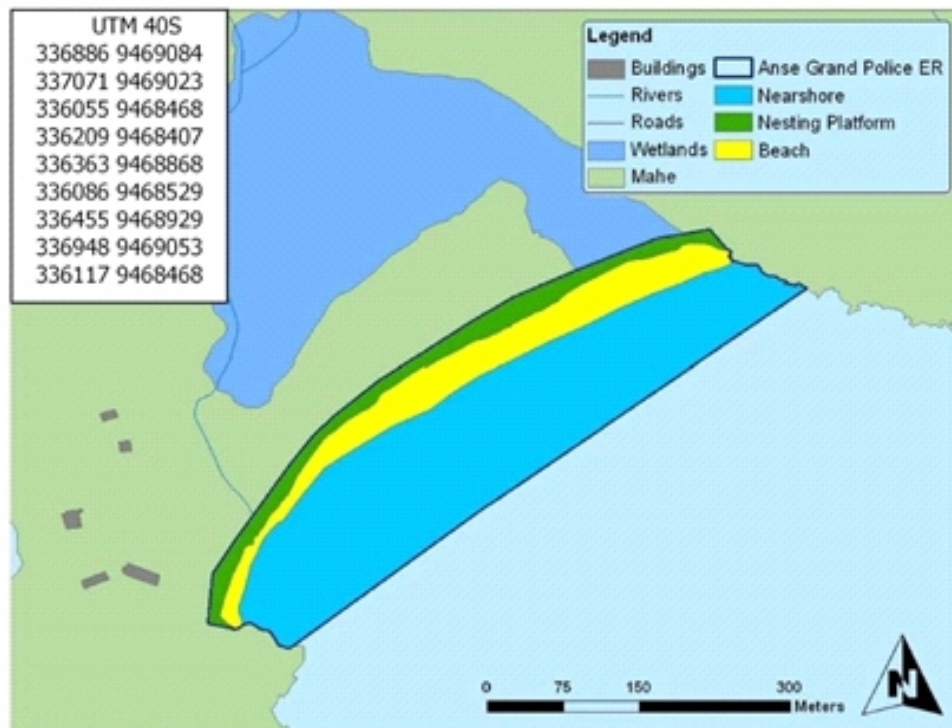


Figure 6. Delineated boundary of nominated site Anse Grand Police.
