# Public Enterprises (Amendment of Schedule 1) Regulations, 2025

In exercise of the powers conferred by paragraph (j) of section 104 of the Public Enterprises Act, 2023 (Act 6 of 2023), the Vice-President, being the Minister responsible for Finance makes the following regulations —

#### Citation

1. These Regulations may be cited as the Public Enterprises (Amendment of Schedule 1) Regulations, 2025.
