Environment Protection (Ozone) (Amendment) Regulations, 2025

In exercise of the powers conferred by section 80 of the Environment Protection Act, 2016 (Act 18 of 2016), the Minister responsible for Environment makes the following regulations —

Citation

1. These regulations may be cited as the Environment Protection (Ozone) (Amendment) Regulations, 2025.

Insertion of new regulation 17A

2. The Environment Protection (Ozone) Regulations, 2010 (S.I. 64 of 2010) (hereinafter referred to as the principal regulations) is amended, by inserting the following new regulation after regulation 17 —

"Standards in respect of natural refrigerants

- 17A.(1) The standards adopted by the Seychelles Bureau of Standards in respect of Hydrocarbons in its guide SS75:2020 (Parts 1 to 4) titled "Refrigerating systems and heat pumps- safety and environmental requirements" shall be applicable in the usage of Hydrocarbons as natural refrigerant.
- (2) The standards adopted by the Seychelles Bureau of Standards in respect of Ammonia in its guide SS Guide 87:2020 titled "Safety Guide-Ammonia Refrigerating Systems" shall be applicable in the usage of Ammonia as natural refrigerant.".

Insertion of new regulation 18A

3. In the principal regulations, after regulation 18, the following regulation shall be inserted —

"Phasing out of high global warming substances and products

- **18A.**(1) With effect from 1st January, 2027, the substances and products containing, made with or designed for the usage of controlled substance R-23 with GWP 14800 shall be phased out from use in the Republic of Seychelles.
- (2) With effect from 1st January, 2029, all products containing or made with or designed for the usage of controlled substance with GWP >3000 shall be phased out from use in the Republic of Seychelles.
- (3) With effect from 1st January, 2030, all products containing, made with or designed for the usage of controlled substance with GWP >2000 shall be phased out from use in the Republic of Seychelles.".
