- in the following municipalities in Aube: Arsonval, Cunfin, Dolancourt and Jaucourt, the demarcated parcel area is that approved by the competent national committee of the *Institut national de l'origine et de la qualité* at its meetings held on 23 June 1994, 8 September 1994 and 19 May 1995, the plans for which have been filed in the town halls of the municipalities concerned;

The quality, reputation or other characteristic of the goods for which the geographical indication is used, and any conditions under which the indication may be used :

The "Champagne" registered designation of origin is reserved for sparkling white or rosé wines.

These wines may be either white (made from a blend of white and black grapes, made only from white grapes [blanc de blancs], or made only from black grapes [blanc de noirs] or rosé (made by blending in some red wine or through skin contact during fermentation). They are made using grapes grown in one or more municipalities and may be vintage or non-vintage wines.

All of the wines have one thing in common : acidity, guaranteeing freshness and suitability for ageing. In the youngest wines, the notes are decidedly fresh; white fruit and flowers, citrus fruit and mineral notes. Mature wines offer a more rounded palette, with aromas of yellow fruit, cooked fruit and spices, while deep tertiary aromas of candied fruit, forest undergrowth and roasting come to the fore in the most developed wines (known as de plénitude).

The bubbles – the hallmark of 'Champagne' – are sustained and persistent in young wines, becoming smoother and more velvety with age.

1. Grapes varieties

The wines are made exclusively from the following grape varieties :

- Main wine grape varieties; Arbane (white), Chardonnay (white), Meunier (black), Petit Meslier (white), Pinot blanc (white), Pinit gris (grey), Pinot Noir (black).

- and the variety "of interest used for adaptation purposes". Voltis (white), subject to the signing of an agreement between the INAO, the ODG, the authorised operator concerned, the operator-winemaker and the producer, in accordance with the framework agreement approved by the competent national committee on 02 June 2021.

2. Rules on planting proportions

- a) The proportion of the main grape varieties is greater than or equal to 95% of the vines planted.
 b) The proportion of a variety "of interest used for adaptation purposes" is less than or equal to 5% of the vines planted.
