NOTICE UNDER SUBSECTION (2) OF SECTION 38

PRESIDENTIAL ELECTION, 2025

In exercise of the powers conferred by subsection (2) of section 38 of the Elections Act (Cap. 262) and paragraph 5 of Schedule 3 to the Constitution of the Republic of Seychelles, I, Wendy DIDON, Chairperson of the Electoral Commission, hereby notify that the results of the Presidential Election held on 25th, 26th and 27th September, 2025, as follows: —

Total eligible voters: 77,045

Total votes cast: 64,809

Total rejected votes cast: 1,870

Total valid votes cast: 62,939

Total valid votes cast are as follows: —

1. Mr. Marie, Alain, Basil, Raoul **St. ANGE** of Lalyans Nouvo Sesel, obtained 513 votes, amounting to 0.8%.
2. Mr. Mathew, Antonio, Patrick **HERMINIE** of United Seychelles, obtained 30,736 votes, amounting to 48.8%.
3. Mr. Kisna **LOUISE** an independent candidate, obtained 68 votes, amounting to 0.1%.
4. Mr. Ralph, Maxime, Gerald **VOLCERE** an independent candidate, obtained 217 votes, amounting to 0.3%.
5. Mr. Robert, Antoine **MOUMOU** of Seychelles People's National Movement obtained 593 votes, amounting to 0.9%.

6. Mr. Charles, Claude **DE CLARISSE** an independent candidate, obtained 253 votes, amounting to 0.4%.
7. Mr. Wavel, John, Charles **RAMKALAWAN** of the Linyon Demokratik Seselwa obtained 29,230 votes, amounting to 46.4%.
8. Mr. Maarco **FRANCIS** of Seychelles United Movement obtained 1,329 votes, amounting to 2.1%.

Pursuant to paragraph 5 of Schedule 3 to the Constitution of the Republic of Seychelles (Cap.42), a person shall not be elected to the office of President unless he or she has secured more than fifty percent (50%) of the votes cast in the election. As no candidate has attained the required majority, no candidate is hereby declared elected as President of the Republic of Seychelles.

Accordingly, in pursuance of paragraph 5 of Schedule 3 to the Constitution of the Republic of Seychelles (Cap.42), the Electoral Commission shall proceed to conduct a second ballot.

Act 25 of 1902**

Road Act (Classification of Victoria Bypass) Order, 2025

1. This order may be cited as the Road Act (Classification of Victoria Bypass) Order, 2025.
2. By the powers conferred under section 18 of the Road Act, the Minister for Transport hereby classifies the Victoria Bypass, a public road extending from North East Point to Anse Aux Pins, in the interest of improving national transport infrastructure.

ROAD ACT

(Cap 205)

Notice to prescribe Building Line

Whereas the Minister for Transport, pursuant to Section 20 of the Road Act, is satisfied that it is necessary and expedient, for the orderly erection of a public highway (hereinafter the “Victoria Bypass”), to prescribe a building line —

- (a) along both of its sides;
- (b) at a distance of 9.00 metres from its centre line;
- (c) for its entire length extending from North East Point to Anse Aux Pins.

And whereas a plan of the building line has been drawn up and deposited at the Department of Land Transport, Mahe and is available for inspection by the public during normal working hours.

Now therefore, persons having objections to the undertaking are requested to submit their written objections to the Department of Land Transport, within six weeks of the date on which this notice is published, specifying the nature of the objection and giving reasons therefor.
