ROAD ACT*(Cap 205)*

Notice to prescribe Building Line

Whereas the Minister, pursuant to Section 20 of the Road Act, is satisfied that it is necessary and expedient, for the orderly erection of a public highway (hereinafter the "Victoria Bypass"), to prescribe a building line —

- (a) along both of its sides;
- (b) at a distance of 9.00 metres from its centre line;
- (c) for its entire length extending from North East Point to Anse Aux Pins;
- (d) the building line is to be situated on parcel V7267.

And whereas a plan of the building line has been drawn up and deposited at the Department of Land Transport, Mahe and is available for inspection by the public during normal working hours;

Now therefore, persons having objections to the undertaking are requested to submit their written objections to the Department of Land Transport, within six weeks of the date on which this notice is published, specifying the nature of the objection and giving reasons therefor.
