NOTICE UNDER SUBSECTION (2) OF SECTION 38 OF THE ELECTIONS ACT

PRESIDENTIAL ELECTION, 2025 (SECOND BALLOT)

1. In exercise of the powers conferred by subsections (1) and (2) of section 38 of the Elections Act (Cap. 262) and paragraph 5 of Schedule 3 to the Constitution of the Republic of Seychelles, I, Wendy DIDON, Chairperson of the Electoral Commission, hereby notify the result of the Presidential Election (Second Ballot) held on 9th, 10th and 11th October, 2025, as follows: —

Total eligible voters: 77,045

Total votes cast: 66,819

Total rejected votes cast: 1,607

Total valid votes cast: 65,212

2. Total valid votes cast are as follows: —

- (1) Dr. Mathew, Antonio, Patrick **HERMINIE** of United Seychelles, obtained 34,389 votes, amounting to 52.7% of valid votes cast.

- (2) Mr. Wavel, John, Charles **RAMKALAWAN** of the Linyon Demokratik Seselwa obtained 30,823 votes, amounting to 47.3% of valid votes cast.

3. I hereby declare Dr. Mathew, Antonio, Patrick **HERMINIE** as validly elected President of the Republic of Seychelles.

CONSTITUTION OF THE REPUBLIC OF SEYCHELLES

Declaration under clause (2) of Article 79 and subparagraph (5) of paragraph 4 of Schedule 3 to the Constitution of the Republic of Seychelles regarding next General Election and the Presidential Election

1. **WHEREAS**, clause (1) of Article 79 of the Constitution of the Republic of Seychelles provides that a general election shall be held at the same time as the election of the President declared under subparagraph (5) of paragraph 4 of Schedule 3 to the Constitution of the Republic of Seychelles. Clause (2) of the said Article provides that the Electoral Commission shall, within 30 days of the declaration of the election of members to the National Assembly following a general election, publish in the Gazette a declaration of the date of the next general election;

2. **AND, WHEREAS**, subparagraph (5) of paragraph 4 of Schedule 3 to the Constitution of the Republic of Seychelles provides that on the date of declaration of the President elect, the Electoral Commission shall declare the date of the next Presidential election and within 30 days of such declaration publish a written declaration in the Gazette. A declaration to that effect was made by the Electoral Commission at the time of declaration of the result of the President elect.

3. **NOW, THEREFORE**, in pursuance of the provisions of clause (2) of Article 79 and subparagraph (5) of paragraph 4 of Schedule 3 to the Constitution of the Republic of Seychelles, the Electoral Commission hereby declares that the next General Election and the Presidential Election shall be held simultaneously on 21st September, 2030.
