SEYCHELLES PENSION FUND ACT

(Cap. 220)

Seychelles Pension Fund (Rate of Interest) Notice, 2025

In exercise of the powers conferred by subsection (3) section 28 of the Seychelles Pension Fund Act, (Cap. 220), the Minister responsible for Finance, upon the recommendations of the Board, determines that the rate of interest payable to members on their contribution to the pension fund are as follows —

- (a) 1.5% on mandatory contributions; and
- (b) 3.75% on voluntary contributions.

2. The rates of interest specified above shall be applicable from 1st January, 2026 until a further notice is published.

Land Reclamation Notification, 2025

WHEREAS, Mr. Alderic Benoiton acting on his own behalf (hereafter referred to as "the Applicant") has applied for authorisation under Section 6 of the Land Reclamation Act (Cap 106) to fill in and reclaim an area of foreshore of approximately 6,000 square metres at La Retraite, adjacent to land previously reclaimed under the undertaking of 6th October 2021 and as per S.I. 93 of 2021 (hereinafter referred to as "the Undertaking");

AND WHEREAS, the Undertaking is demarcated by the coordinates specified under the Schedule and the plan illustrated thereunder and are available for inspection at the Seychelles Planning Authority's Office at Independence House and may be viewed on its website "www.spa.gov.sc";

AND WHEREAS, the Undertaking also provides for a total maximum excavation area of approximately 13,112 square metres to a minimum depth of minus 2 metres Above Chart Datum (ACD) as shown coloured blue on the plan to provide for a navigational channel for all tides access by boat owners and fishermen in the area;

AND WHEREAS, the Applicant has agreed to the terms and conditions that in consideration of the Applicant carrying out the Undertaking at his own costs, the Republic will, upon completion of the Undertaking, including the undertaking of 6th October 2021 as per S.I. 93 of 2021, transfer eight portions of land marked A, B, C, E, F, H, I and J having a total area of approximately 10,680 square metres to the Applicant, representing approximately 63.3% of the total area reclaimed. The Republic will retain in its ownership at no cost to it, the following portions of land, representing approximately 36.7% of the total area reclaimed:

- (1) a 6 metre strip of land of approximately 2,956 square metres in area along the public road boundary of the Undertaking of 6th October 2021 as per S.I. 93 of 2021 for road widening purposes, construction of pedestrian walkways, drains and landscaping;
- (2) Area G - an area of approximately 1,057 square metres to provide for future construction of the bridge, abutment and road intersection for the proposed Ile Aurore/La Retraite Road link in addition to an open area of foreshore for public recreational use;
- (3) Area K - approximately 2,005 square metres in area for housing purposes;
- (4) Area D – an area of approximately 173 square metres to provide for additional off-road parking.

AND WHEREAS, the President is desirous of authorising the reclamation of the Undertaking or the performance of other works over and upon the foreshore specified under the Schedule and the plan illustrated thereunder by the Applicant;

NOW, THEREFORE, in exercise of the powers conferred by section 6 of the Land Reclamation Act (Cap 106), the President hereby authorise reclamation of the Undertaking and notify the same as required under section 6(2) and the rules under Second Schedule and any person having any objection to the Undertaking or any claims of private right in respect thereof may lodge his or her objection or claim, in writing, to the Chief Executive Officer, Planning Authority at the Planning Authority's Office, Independence House or by email to ceopa@mlh.gov.sc not later than two months from the date of publication of this notice in the *Gazette* specifying the nature thereof and giving an estimate of any loss which may be incurred by reason of the extinguishment of any private right.
