**WRITTEN INSTRUMENT ISSUING AND ESTABLISHING A COMMISSION
OF INQUIRY**

IN THE MATTER OF Section 3 of the Commission of Inquiry Act (Cap 44) of the Laws of Seychelles

AND IN THE MATTER OF The Incident which occurred at Montagne Posee Prison on the 6th to 7th December 2020, resulting in deaths, injuries, and serious allegations concerning the use of force.

PREAMBLE

AND WHEREAS an Incident of grave seriousness occurred at the Montagne Posee Prison from the 6th to the 7th day of December 2024 resulting in deaths, injuries, and serious allegations concerning the use of force;

AND WHEREAS this Incident resulted in the tragic loss of life of two prisoners, namely, Francis Ernesta and Jerry Mathiot, and caused physical injuries to several other prisoners;

AND WHEREAS there are serious allegations and public concern regarding the nature of the Incident, the response by state authorities, the use of force and weaponry, and the chain of command during the said Incident;

AND WHEREAS it is in the public interest, and essential for the administration of justice, the maintenance of the rule of law, and the protection of human rights, that a full, independent, and impartial investigation be conducted to ascertain the facts and circumstances surrounding the said Incident;

AND WHEREAS I, Dr Mathew Antonio Patrick Herminie, President of the Republic of Seychelles, am satisfied that the circumstances pertaining to the above-mentioned are of vital public interest and concern;

NOW, THEREFORE, I, Dr Mathew Antonio Patrick Herminie, by virtue of the powers vested in me by section 2(1) of the Commission of Inquiry Act, 1962 do hereby appoint, constitute, and issue as follows:

ARTICLE 1: INTERPRETATION

In this Instrument, unless the context otherwise requires, the following terms shall have the meanings ascribed to them below:

“**INCIDENT**” means the Incident that occurred at the Prison on 6 to 7 December 2024, resulting in the deaths of two prisoners, namely Francis Ernesta and Jerry Mathiot, and physical injuries to several other prisoners;

“**PRISON**” means the Montagne Posée Prison, situated at Montagne Posée and declared a prison under the Prisons Act.

ARTICLE 2: ISSUE OF A COMMISSION AND APPOINTMENT OF COMMISSIONERS

- 2.1. There shall be a Commission of Inquiry which shall be known as “The Montagne Posée Prison Incident Commission of Inquiry” (hereinafter referred to as "the Commission").
- 2.2. The Commission shall consist of Hon. Justice Justice Alfred Mavedzenge, Hon. Judge Melchior Vidot and Mr. Vic Tirant.
- 2.3. Hon. Justice Justice Alfred Mavedzenge is hereby appointed as the Chairman of the Commission.

ARTICLE 3: TERMS OF REFERENCE

The Commission is hereby mandated and required to inquire into the following matters and to report its findings, conclusions, and recommendations to my office:

3.1 Nature and Cause of the Incident

- (a) To establish the facts and chronology of the Incident.
- (b) To determine whether there was a riot, disturbance, or planned action by prisoners, and if so, to investigate the cause(s), nature, and extent of such riot or disturbance.
- (c) To identify the grievances, if any, of the prisoners that may have contributed to the Incident.

3.2 Response of the Authorities

- (a) To investigate the response of the Prison Authorities, the Seychelles Police Force, and the Seychelles Defence Forces (SPDF) to the Incident.
- (b) To evaluate whether the response was reasonable, necessary, and proportionate in the circumstances.
- (c) To ascertain the chain of command in respect of the authorities' response, from the initial report to the resolution of the Incident.
- (d) To identify all persons responsible for giving orders during the Incident, and to ascertain the specific orders given at each critical stage.

3.3 Use of Force and Weaponry

- (a) To determine what types of weapons, ammunition, and non-lethal equipment were authorised for use and were actually used by personnel during the Incident.
- (b) To investigate the type, degree, and circumstances of all physical force used against prisoners.
- (c) To establish the precise circumstances under which the two prisoners, Francis Ernesta and Jerry Mathiot, lost their lives.
- (d) To establish the circumstances under which other prisoners were physically assaulted, shot, or otherwise injured.

3.4 Personnel and Command Accountability

- (a) To identify the individuals involved in dealing with the Incident, from the highest levels of the chain of command to the individual officers and officials on the ground.
- (b) To determine the highest authority involved in authorising and overseeing the response to the Incident.

3.4 Broader Implications

- (a) To consider whether there was any violation of human rights, including but not limited to the right not to be subjected to torture, cruel, inhuman or degrading treatment or punishment.
- (b) To consider whether the actions or omissions of any person(s) may constitute criminal offences, disciplinary breaches, or other misconduct, and if so, to recommend appropriate referral to the relevant authorities.
- (c) To assess the adequacy of existing protocols, rules of engagement, and training provided to prison or security personnel for the management of serious disturbances in custodial facilities.
- (d) To consider any other relevant matters that the Commission deems necessary to fully investigate the Incident and its causes and consequences.

ARTICLE 4: POWERS AND PROCEDURE

- 4.1. The Commission shall, for the purpose of its inquiry, have all the powers conferred upon a Commission by the Commission of Inquiry Act, including the power to:

- (a) Summon any person to attend before it to give evidence or to produce any document or thing in their possession.
 - (b) Examine witnesses and parties concerned on oath, affirmation or declaration, as the case may be.
 - (c) Where the Commission considers it desirable for the purpose of avoiding expense or delay or for any other special reason, receive evidence by affidavit or administer interrogatories.
 - (d) Do all such other things as are necessary for the proper fulfillment of its mandate, including the power to require the production of any relevant documents or information.
- 4.2. The Commission may engage and appoint such experts as it deems necessary to assist in its work and to provide expert opinion and analysis on any matters within the Terms of Reference specified in Article 3.
- 4.3. The proceedings of the Commission shall be held in public, save for where the Commission, for reasons of national security, the protection of witnesses, or the administration of justice, determines that certain proceedings should be held in camera.

ARTICLE 5: REPORT

The Commission shall submit to my office a final written report of its inquiry, including its findings of fact, its conclusions on the matters specified in the Terms of Reference specified in Article 3, and any recommendations it considers appropriate, within a period of six months from the date of its first sitting, or such further period as I may subsequently authorise upon a request by the Commission.
